

SCHEDULE A
FOREST DEVELOPMENT ROAD COOPERATION AGREEMENT
LEWIS COUNTY, WASHINGTON

Forest Service Roads on which all maintenance will be the responsibility of the Cooperator except direction signs.

- A. Snyder Road No. 1260, Starting at mile post 0.59 in the NE1/4 NE1/4 of Section 22, Township 13 North, Range 9 East, W.M., being 0.62 miles in length and ending at the junction with Forest Road No. 1260022 at mile post 1.21 in the NE1/4 NW1/4 of Section 23, Township 13 North, Range 9 East, W.M.
Remarks: Clear up right of way problems and bring to County standard.
- B. Powerhouse Road No. 1261, Starting at its junction with Snyder Road in the NW1/4 NE1/4 of Section 22, Township 13 North, Range 9 East, W.M., being 0.37 miles in length ending in the SE1/4 NE1/4 of Section 22, Township 13 North, Range 9 East, W.M.
Remarks: Easement transfer needed when road is brought up to County standard.
- C. Wold Road No.5204, Starting at its junction with Skate Creek Road North in the NE1/4 NE1/4 of Section 5, Township 14 North, Range 7 East, W.M., being 0.65 in length and ending at its junction with Forest Road No. 5204015 at mile post 0.65 in the NE1/4 SE1/4 of Section 32, Township 15 North, Range 7 East, W.M.
- D. Cispus Road No. 2300, Starting at mile post 2.44, being the Forest Service Boundary in Government Lot 3 in Section 27, Township 12 North, Range 7 East, W.M., being 5.75 miles in length and ending at its junction with Forest Road No. 2800 at mile post 8.19 in the SE1/4 SW1/4 of Section 8, Township 11 North, Range 8 East, W.M.
Remarks: Project Agreement brought road to standard. Culvert replacements needed. Right of way easement pending.
- E. Cispus Road No. 2800, Starting at mile post 8.19, its junction with Forest Road No. 2300 in the SE1/4 SW1/4 of Section 8, Township 11 North, Range 8 East, W.M., being 1.34 miles in length and ending at mile post 9.53, its junction with Forest Road 7600 in the NE1/4 NW1/4 of Section 20, Township 11 North, Range 8 East, W.M.,
Remarks: Project agreement brought road to standard. Right of way easement pending.
- F. Cispus Road No. 7600, Starting at its junction with Forest Road 2800 at mile post 9.53, in the NE1/4 NW1/4 of Section 20, Township 11 North, Range 8 East, W.M., being 0.57 miles in length and ending at mile post 10.10 this point being the section line between Sections 17 and 18, Township 11 North, Range 8 East, W.M.
Remarks: Right of way easement pending.

- G. Cispus Road No. 7600, Starting at the section line between Sections 17 and 18, Township 11 North, Range 8 East, W.M. at mile post 10.10 being 1.66 miles in length and ending at mile post 11.76, its junction with Cispus Drive in the NW1/4 NW1/4 of Section 13, Township 11 North, Range 7 East, W.M. Remarks: Right of way problems and substandard roadway. Need project agreement to correct.

Forest Service Roads on which all maintenance is responsibility of the Cooperator.

- A. Coal Creek Drive No. 1268, Starting at its junction with U.S. Highway 12 in the NW1/4 of Section 6, Township 13 North, Range 10 East, W.M. being 0.10 miles in length and ending the section line between Section 6, Township 13 North, Range 10 East, W.M. and Section 1, Township 13 North, Range 9 East, W.M. being the Forest Service boundary.
Remarks: Easement pending.
- B. Forest Service Road No. 63, From Davis Creek Road centerline in the Southeast Quarter of the Southwest Quarter (SE1/4 SW1/4) of Section 9, Township 12 North, Range 8 East, W.M., North for 0.016 mile.

Forest Service Roads on which maintenance will be the responsibility of the Forest Service, but on which the Cooperator may at its option participate in improvements upon approval of the Forest Service.

- A. Skate Creek Road No. 5200, Starting at its junction with Forest Road No. 5204 (Wold Rd) at mile post 3.35 in the NE1/4 NE1/4 of Section 5, Township 14 North, Range 7 East, W.M., being 17.75 mile in length and ending at its junction with Terrace Way at mile post 21.1 in Government Lot 6 in Section 9, Township 13 North, Range 9 East, W.M.

Forest Service Property used for wetland mitigation for projects on roads within the National Forest Boundary. Plantings and maintenance thereof to be the responsibility of the Cooperator.

- A. Forest Service Property lying south of and adjacent to Davis Creek Road between Mile Post 0.08 and 0.21, described as that portion of the Southwest Quarter of the Northwest Quarter of the Northeast Quarter (SW1/4 NW1/4 NE1/4) of Section 17, Township 12 North, Range 8 East, W.M., lying South of Davis Creek Road.

The parties agree that the maintenance obligations of the Contractor set out above do not permit the Contractor to identify and remove trees which pose or may pose a danger to roads or to road users. Danger tree identification and removal remains the sole right and obligation of the U.S. Forest Service

It is understood that as part of this agreement, Forest Service may grant to Cooperator, the permissive use of sites on its lands for temporary waste disposal and stockpiling of

materials, related to the maintenance of the above roads, the specific terms for such use to be agreed upon by Forest Service District Ranger and County Engineer.


